Full Terms & Conditions

M&S Sparks Pay Offer – 20% off at M&S Terms and conditions

We are offering 20% off at M&S in accordance with these offer terms and conditions (the Offer Terms) when you successfully apply for Sparks Pay and meet the eligibility criteria set out below.

- 1. These Terms apply in addition to and should be read together with the Sparks Pay Terms and Conditions. In the event of any conflict between these Terms and the Sparks Pay Terms and Conditions, these Terms will apply.
- 2.In these Terms "we", "us" or "our" means M&S Bank. M&S Bank is the trading name of Marks & Spencer Financial Services plc, part of the HSBC Group. "M&S" means Marks and Spencer plc.

Eligibility criteria
